COURSE INFO: Oak Hills Park Golf Course, built in 1969 and designed by Alfred Tull, is an 18-hole municipal golf course located in Fairfield County. Greens are primarily a mix of Bentgrass and Poa Annuua. Tees and fairways are Bentgrass and Ryegrass. Toro LTC Plus irrigation system with site pro was installed in 2000 and the pump house upgraded in 2010 to meet DEP usage regulations. The course is a challenging 6,317 yard par 71.

RESPONSIBILITIES: Reports to Executive Director coordinating operations with Greens Chairman of the Golf Authority and Golf Professional. The Superintendent is responsible for all aspects of maintenance for the golf course, grounds and clubhouse as well as development of the maintenance department's annual operating and capital budgets and efficient use of those funds. Must be dedicated to providing respectful mentoring and motivation of the staff for maximum productivity. Should be visible and attentive to the membership with a willingness to address their concerns for the golf course and overall grounds maintenance. Must be open to a flexible work schedule.

QUALIFICATIONS: Experience as a Superintendent or 1st Assistant Superintendent at a private club or public course with proven results in maintaining quality conditions. Completion of a four-year bachelor's degree in turf and turfgrass management from an accredited university is preferred. GCSAA certification preferred but not required. Must be a member and active participant in on-going education of GCSAA and local chapter. Must possess a Connecticut pesticide applicators license, or be able to obtain one within 120 days of employment. Prospective candidates must have a proven track record of working with club membership, greens committee and course management to implement plans for consistent improvement of the golf course. Must exhibit strong verbal and written communication skills. Must be computer literate with ability to access various resources for up-to-date agronomic information and be environmentally sensitive and willing to comply with environmental regulations. Candidates should have experience undertaking projects above and beyond daily maintenance, including potential renovation and construction work.
