Job examples: 1. Inspects ponds, lakes and other bodies of water to identify aquatic weed/ algae infestation and determine corrective action. 2. Prepares and applies aquatic algacides, herbicides, biological controls and aeration equipment. 3. Operates open and closed spray equipment; orders and maintains an inventory of product and equipment. 4. Completes and Files DEP / DEC / EPA Permits 5. Keeps accurate records of all pesticide use; prepares, maintains, and submits reports required. 6. May lead a crew as required. 7. Performs other related duties as required: fish stocking, bathymetric surveys and account management. 8. Attends meetings and trade shows
- EDUCATION:** Any combination equivalent to: Graduation from high school; and experience in landscape/turf grass maintenance or agriculture that includes application of pesticides. License/Certificate Requirement: Possession of a valid Driver's License; ability to remain insurable.
