

SUNY Delhi SUMMER 2009 INFORMATION SHEET & FINANCIAL AID APPLICATION
READ THE FOLLOWING CAREFULLY
ALL CONDITIONS AND DEADLINES APPLY TO SUMMER AID

- A valid 2009/2010 electronic Student Aid Report (the result of filing a FAFSA), and all required documentation and forms, must be received by the Financial Aid Office no later than May 1st.
- Summer aid is contingent upon spring academic grades. Any student who *does not* meet the SUNY Delhi [Satisfactory Academic Pursuit and Progress](#) standards after spring term will **HAVE ALL SUMMER FINANCIAL AID CANCELED**.
- **NOTE:** We recommend that you have money for books and living expenses, because summer aid is generally **NOT** available until **after** the summer term begins. **Tuition is due the first day of class, so you may also need money to pay your tuition bill, if your financial aid is not completely processed by that date.**
- You must be registered for the summer and fall terms before your summer aid can be processed. . No aid will be processed for non-registered students.
- You must **COMPLETE** no less than six (6) credit hours of study to be eligible for loans in the summer term. If you withdraw or drop below 6 credits, you will lose **all loan** aid. Your grant aid, if eligible, could also be affected.
- You must maintain a valid current permanent and local address with the Office of Records & Registration.
- All notifications regarding summer financial aid will be by email to your SUNY Delhi email address.
- Workload and funding limitations may make it impossible for Financial Aid to revise summer awards. You will be expected to finance your summer program with the funds initially provided.
- Completed, **signed** forms must be submitted as soon as possible to 109 Bush Hall, as an email attachment to financialaid@delhi.edu, or faxed to 607-746-4104.
