Meeting called to order at 4:31 pm by Presider A. Krause via Zoom

Motion to approve the June 13, 2022 minutes: G. Salerno; seconded: D. Gulotty; 18 Y, N 0, 3 abstentions; passed

<u>Introductions:</u> College Senators introduced themselves (we have an Ambassador red-tail hawk—ask G. Salerno if you are interested in a guest)

Updates:

Office-in-Charge:

- Thanks for volunteers at check-in and Welcome Weekend: students did well with COVID testing (two positives and they didn't arrive on campus); students were very engaged in activities; we are grateful for all of the orientation leaders and student life activity planning for this weekend; good participation in convocation
- Starting Mentoring Program: at 50, looking for more volunteers; Q: online too, A: yes, we will try to pair people; first meeting is tomorrow; Q: How does this work with Road 2 Success and other programs from last year; A: If with a group last year, you are still with them, but if not, they can give you students; Contact J. Padovani or J. Stedman if you are interested; will provide resources
- Will be a lot of information on Workforce Development and CHIPS and Science Act fund (domestic semiconductors); more information soon
- Partnership with DOL and apprenticeships
- Funds from workforce development and Inflation Reduction Act

- President's meeting: Cobleskill has a partnership with DOT, see if we can partner as well
- M. Sullivan working with SUNY Oneonta, and will be working with Binghamton
 University to see if students that are not accepted/don't go there will consider Delhi
- SUNY has hired an enrollment person; they did some work at SUNY Oswego yielding 500 new students; trying to keep students within SUNY
- Strategic Enrollment Planning Committee: would like volunteers, and can provide feedback online
- Will put out more on budget and ask for feedback on ways/ideas to save or increase revenues
- Going to community events, Chamber of Commerce, etc.

Provost:

- Cecilia DeCotes is new Assistant Dean of ADN Program
- Dan Davis will be serving as Interim Dean in School of Applied Technologies and Architecture-thanks Dan!; hoping SED approval on BArch soon
- Andrea and Larry-thanks for help with Convocation
- SED approved name change to BBA in Accounting (was "Accounting: Information Systems Auditing")
- We are in cohort 3 of D2L Brightspace; Callas Center and others will be reaching out about this
- Keep using Starfish for now; please lower the flags once you have met with the students
- Academic Policy Committee: Universal grading system needed for Middle States and for allowing students to transfer easier between programs
- Low enrolled courses: there is no policy on this, was told classes needed 8 to run, but at some point in the past it was 10; Fall '21 183 courses with less than 8 students, 146 without counting internships or advanced study; spring 129 ran under-enrolled without internships or advanced study
- Working with consultant, Anna, and L. Edwards to look at curriculum planning; trying to plot out fall and spring going forward; 54 adjuncts were hired last year and this fall we are at 58
- Q: count of under-enrolled courses, some have low caps set intentionally (ex. Vet Sci.); A: was not looking at those types of courses separately
- Q: appreciate need to save \$; if closing a 100-level under-enrolled class can understand this decision, however, students need specific 300-level courses for their degrees, students are having 2-3 upper-level classes cancelled, we are paying another institution to offer the course in one case; can we look holistically going forward at how closing a class impacts students; A: 9 times out of 10 allows upper-level classes are allowed to run; can look at individual students to make sure this isn't happening; students can take required class next semester if they are not near graduation

- Q: session B or K classes are cancelled before students know they need it; students transferring out of nursing may need to drop nursing courses and add B-session, etc.; please do not cancel these classes so early A: Not good idea to cancel 1 week before classes start; if we do it two weeks before, we are told it's too early
- Can create policy for class closings
- Anna's document will look at historical record to anticipate in January what we need in terms of classes in the fall
- Q: is the number staying at 8?; A: let some go at 7
- Q: Nursing clinicals look like 4 in class, but it's because of the way instructors are spread and requirements for nursing; B. Finn-Maguire will help if there are questions there
- Provost will filter out courses with low caps for set reasons (Nursing, Vet Sci., etc.)

Presider:

- Updating Vancko Hall, will shift to using Sharepoint more due to upcoming D2L transition
- Duties of Senator
 - Two trainings will soon be available in VH:
 - one on Shared Governance-we are working to rebuild and define/refine processes as we go forward;
 - one on Robert's Rules of Order- this is what we use for meetings, there will be a cheat sheet too
 - Make a main motion, seconded by Senator, then opened for discussion (guests can speak too once recognized); speak to the Presider in your comments; then vote to approve, vote against, or abstain (not counted as a vote for or against)
 - Q: Where are we getting documents from? Senior Council Meeting, Mr. Landa presented on Shared Governance; A: SUNY materials will be used; we are a part of SUNY University Faculty Senate system; some of the specifics of how we do things locally is still in development
 - Serve on a Senate Committee, or serve as a Senate Rep. on another Campus
 Committee; much work is done outside of Senate proper in Committees
 - We will locate where there are openings and will discuss committee options with you
 - Committee Work is important
- Goals from CET survey: things people said they wanted to see improved: transparency, clarity of processes and structures, inclusiveness, effectiveness, and opportunities for participation, like values for shared governance; Alice will be reaching out to you and with the O-I-C to operationalize values into things we can assess
- Looking at rubrics from SUNY and SUNY awards in Shared Governance, and trying to progress toward assessing and applying for award

Old Business

C. Rossi (Operations Committee): In need of secretary, no volunteers yet; do not need Senate Experience, 2-year role and sits on Eboard; Q: responsibilities of secretary; A: keeps minutes, distributes minutes and agendas, maintains VH and College Senate website

L. Tessier (Resolutions Committee): described the local and SUNY UFS Resolution processes (see process in Vancko Hall); Approved resolutions go to the Admin. for written response and implementation (if they so choose); these are a way to move forward on shared causes; Reintroduced the local Telecommuting Resolution (based on SUNY UFS Resolution 189-03-1); Senators should gather feedback from their constituents and be prepared to share and vote at next meeting.

New Business

C. Rossi (Operations Committee): seeking nominations for a Parliamentarian, need to know Robert's Rules, or be willing to learn; contact Cheri if you are interested; do not need to be a Senator; if you are a Senator, you would give up your seat (for neutrality); if serving as interim parliamentarian, you would maintain speaking and voting privileges
