Updates: E-board

Lisa T. and Alice K.: Plenary held at SUNY Purchase. Lisa T. has prepared report for November with update at future meeting. Lisa T. shared some insights: Budget challenges are across SUNY in general. Faculty and staff burnout was also discussed. A statement containing four new resolutions will come forward for discussion in subsequent meetings so stay tuned.

Old Business

Bylaws Proposal – Lindsay Walker (Bylaws Committee)

Wording on paragraphs changed. Dean section changed. Separated into sections for ease of viewing. Timing has not changed on anything.

Motion to approve made by Doug H. and seconded by Shelly J.

Kristy F. wondered if the wording on "learning management system" could be more generalized as we are in the process of moving to MS Forms. More generic language would allow flexibility from this angle.

Kristy F. made motion to amend and Terry H. seconded.

Amendment suggested: Change "through current management system" to "learning management system or similar means" and change wording that suggests election results will be shared through learning management systems to simply state the election results will be shared.

Vote taken: yes -20; no -0; abstain -1. Amendment to By-laws Proposal passed.

Motion to approve resolution already made.

Vote taken: yes -21; no -0; abstain -1. Bylaws change approved.

UFS Resolutions – Lisa Tessier (Resolutions Committee)

Last two from Spring Plenary:

A vote to endorse the health and wellness resolution to expand offerings for faculty and staff.

The asks are to the SUNY Chancellor to endorse the resolution, name a committee, and also try to fund and deploy a network a chief wellness officers on all SUNY campuses, including ours.

Motion to endorse made by Terry H. Seconded by Lindsay W.

Discussion:

Genevieve S.: Constituents are in favor of this resolution, but are hopeful this will not impact our campus financially.

Jennifer C.: Constituents expressed positivity that health and wellness of SUNY employees is being looked into, but they voiced concern that studies have shown this does not solve burn out. Hiring more people to reduce workload, and therefore reduce burnout, may be a more effective use of funds and time.

Cheri R.: Shared similar feedback as Jennifer C. Opportunities to improve physical and mental health for SUNY employees is welcome, if the methods and models employed are evidence-based and not a result of following trends.

Vote to endorse: yes - 20; no -2; abstain -3. Motion passes

Motion to endorse recognition of Elizabeth Bringsjord's service.

Motion to endorse was made by Terry H. and seconded by Shannon S.

Discussion: none

Vote taken: yes -26; no -0; abstain -1. Endorsement passed.

New Business

UFS Statement – Lisa Tessier (UFS Senator)

Support of basic human rights for all Iranians following recent protests.
