Meeting Minutes

E-Board Updates

- Letter is written and will be going to Gwen Kay to start process
- Met with the President to discuss updates including the Consultation process
- Liz reached out to Provost regarding the Academic Planning Committee to advocate for faculty being on this committee
- USF Plenary is coming up this week (Thursday, Friday, Saturday) Lisa and Liz will be attending and will report back at the next meeting
- Alice when we reached out regarding more faculty on Academic Planning Committee, what was the reaction? Liz – there was a willingness to consider it, but thought the Deans representation was sufficient; concerns making the committee too large. Alice this is a concern that came up repeatedly in the Consultation feedback and should be considered.

Curriculum Committee Update - Alice Krause

- Compiling CC20-1 through CC20-4 together as these are all about adding online/internet format for a mode of delivery for various ARTS courses (ARTS 103, 110, 115, and 250). Motion: Erin Wagner; Second: Jason Cash; motion passes (1 no, 2 abstentions)
 - Following the vote there was discussion regarding Applied Lab versus applied learning – listing of all applied learning attribute – none of these courses are listed – the change to studio will not impact this (Susan Deane) – Nancy (registrar) did not mention this – not an issue;
- CC20-5 withdrawn at Curriculum Committee
- CC20-6 another proposal to add online/internet format as a mode of delivery for HUMN 102 Intro to Music. Motion: Dan Gashler; Second by Donna Cutting. 1 abstention – motion passes
- CC20-7 through 24 were all tabled at the Curriculum Committee meeting. Alice encouraged the Criminal Justice program to revise and improve these proposals so they would be top-notch for the proposed MS degree in Criminal Justice.

Resolutions Committee Update - Lisa Tessier

- Met today for first meeting of year; will need an additional participant this year; focusing on amending the process; looking to have an official response from administration for resolutions passed through senate; will bring this amended language forward to next Senate meeting; pre-resolution of case manager at health center – in August we felt to table that bc health center was restructuring and wanted the language of the resolution to best reflect their needs; with Lori's retiring – they're one dept with 2 co-directors (health and counseling) – unclear what structure will be like going forward b/c of pandemic – putting this resolution on hold until we know more;
- Past resolution lactation spaces hold onto this resolution given budget and campus being closed to general community
- Continue to advocate for previous resolution regarding online class cap
- Dan and Jason will be amending hazard assessment resolution
- New resolutions UFS has resolutions that they will bring forward at plenary
- New resolutions advocating for more faculty voice in academic planning processes

Academic Planning Committee Update - Lisa Tessier & Dan Gashler

- Tentatively discussed for Spring Schedule Dr. Jordan and Dr. Deane can jump in as well;
- Start date of Feb 1 online; Feb 15 face to face coursework for hands on labs; second wave of students later unclear; LA&S will be asynchronous because the labs will be compressed again; no break in the Spring all end May 14 (including finals week); J session start feb 1; K end may 14;

- Students want to feel connected to their instructors
- Concerns about academic freedom re: mode of delivery and knowing best practices
- Importance of quality course design and training (give faculty time to know what the plan is and implement that plan)
- Respondus issues re: server
- What is guiding our planning are we trying to reduce our number?
- Advocated for course caps online; faculty/staff input in process; hazard assessment of the class spaces
- Ward if our classes start Feb 1 and tech students go to lab on Feb 15, how are we expected to run classes that are majority tech students (chaotic start this semester unsure how to meet/start the semester; Provost challenge of doing classes synchronous vs asynchronous; students will be aware that their classes will begin and start online earlier; logistics still need to be ironed out but asynchronous will help allow students to take compressed in-person classes;
- Alice the way courses are listed is very confusing for the students (asynchronous vs synchronous); how this is communicated needs to be clear; students don't understand what asynchronous vs synchronous means necessarily
- Provost parental concerns as well regarding what their students are doing and what their tuition is paying for;
- Susan Deane solutions can't be one size fits all because of our very diverse programs; Nancy/registrar making attributes for synchronous/asynchronous for courses online; need to articulate this to students and parents; looking back at what we put out this semester and revise this for clarity;

Budget Presentation - Carol Bishop

- Carol has shared this with Leadership, Academic Council, UUP executive board;
- Looking at 4 year trends
- Info from the state changes quickly and frequently many unknowns surrounding state support
- Fall 2020 operating budget process is complete; this is available in Confluence link went out in Delhi Today; Mary Wake and Ward Shaffer are our Senate reps on the Budget Committee
- SUNY-wide spending controls and hiring freeze
- 10% state support tax cut for the previous year (retroactive)
- 20-21 Tap/Excelsior awards funded at 80%
- Delhi issued student refunds for Spring 2020
- University-wide programs funded at 25% (e.g. EOP, Access & Equity)
- Additional min 20% reduction in state support for 20-21
- Enrollment decline

- Annual operating disbursements payroll is the bulk of our operating costs; spending control plan in 2020 did work (saved almost 2 million in comparison to previous year)
- Need to take action to get us through financial future as we wait for state funding
- Need to think about prioritizing (academic program evaluations; identify services to reduce or eliminate; possible layoffs/retrenchments)
- Don how long can we self-sustain in this direction? Unclear until we know what's happening with state funding; by end of calendar year we will know more; 25% minimum reduction we need to plan for; heavily reliant on enrollment;
- Alice FTE what does this slide really mean? Instructional (faculty) vs non-instructional people/positions; full-time positions; increase in non-instructional (approx. 30) compared to faculty over same time (approx. 2 positions)
- Alice next slide is this what we call the reserves? (historical cash balances) for lack of a better term, yes; we frequently get asked the question "where did the reserves go?" seems like the numbers fluctuate a lot Carol this is a very high level analysis; have there been increases in the spending to go along with this? Spending slide.
- What's in Confluence is each dept's request for 2020-21;
- Hiring freeze replaced faculty except for 1; non-faculty positions holding vacant as well;
- Dan some of this data goes back to 2016, do you know what the cash balances in June 2016 – started with 20m; this pattern has been consistent for the past few years; 80% of our revenue comes from enrollment;
- Lisa T seems like this shows that our spending was going up at the same time there were concerns about enrollment; put in spending controls more recently some of this seems pre-Covid though; decline in revenue due to enrollment; state support issue because of Covid; we could not have predicted a cut in state support in April;
- Shelly reserves were at 6 million as reported at the 10/7/19 Senate meeting; how? Difference between restricted versus non-restricted funding;
- Tom P does your team create different models of what if's? Carol we started in the spring, but b/c the numbers change so quickly, we stopped we're at the state's mercy;
- Terry what else can be done short-term/long-term to control spending? Continue to do spending control (explain why spending is critical when someone wants to buy something); short of staff, there isn't a lot to cut (spending money on testing, Covid, additions to the budget; energy/heat; cleaning supplies);
- Don Are we looking to lower our requirements for enrollment to increase enrollment? Rob: we are looking to working with the Deans to think about where are students are succeeding and increase retention; Rob's happy to go over enrollment numbers at a future Senate meeting; the market of students has changed; certain program areas – industries are falling apart; need to have conversations with academic areas regarding modes of delivery, title changes (attract more students); would rather have students who will succeed and stay and graduate rather than a rotating door of students;

- Terry Sees reserves as a rainy day fund so the historical cash balances graph makes it look like we're funding the deficit; some of this is restricted – but at some point it may or may not be restricted anymore;
- Jason F do you know how are cash balances compare to other campuses? Carol unclear, there are some that weren't financially stable before and aren't now; state looks at SUNY as a whole – SUNY has the majority of the state's cash;
- Liz are we one of those unstable campuses? Carol no, we aren't; the more money we have, the better obviously – but right now we're able to pay our bills – unclear if we'll have a lot when we get through this;
- Erin W. Thanks, Carol, for taking time to answer our questions; looking at the Confluence document – a few places went up in the budget whereas most areas went down; Carol didn't go through the budget line by line – still under the spending control – so they had to submit a justification for why critical before approved;
- Alice big uptick in disbursements in 2018-19; is that a combination of the UUP raises and the additional hires yes;
