Shared Governance and Senator Training – E. Frisbee

- A modified version of the training that FCCC & UFS created outlining our shared responsibility for and to our campus
- Emphasizing the differences between policy-making and procedure
- The importance of communication and representation
- Decision-making structures: Senate vs Union matters
- Important that each sector understands their role and communicates effectively
- This presentation will also be available on the Vancko Hall Senate page for you to revisit at your leisure

Preferred Name Policy Proposal – presented by T. Aguirre

- This policy and the resolution from the students were posted in Vancko Hall for review prior to the meeting
- Here in lieu of Jarvis, who spearheaded this on the Diversity, Equity, and Inclusion Task Force
- Modeled after other SUNY schools' policies

- Describes the process by which someone can choose to use a preferred name for any reason
- SUNY Faculty Senate also passed a resolution on this in 2015
- Senators: take this policy back to your areas and share this widely with your groups; get feedback for discussion and a vote at the next Senate meeting
- Discussion:
 - o Where would this policy live?
 - In multiple places (e.g. Student Handbook, Faculty/Staff Handbook) depending on the audience would allow anyone part of the community (e.g. faculty/staff/students) to use their preferred name in places where we are not required to use someone's legal name (e.g. legal documents).
 - How can we get this on the books as expediently as possible?
 - We've already been doing it on a case by case basis, so the process is already in place.
 - A lot of times we approve a policy, and then it's unclear where to find it/where it will be posted. It might help to put this information in the policy itself.
 - Need to make sure we can use the preferred name in Vancko Hall, especially when VH is often the classroom space itself.
 - o Diversity, Equity, and Inclusion Task Force is an ongoing committee.
 - After this is supported, timeline and work flow for the changed procedures will be forthcoming.

Assessment Steering Committee Senate Representative & UFS Representative – E. Frisbee

- K. Bucci has asked to have a Senate representative on the Assessment Steering Committee (current members already on the committee: A. Balcom, D. Krzyston)
 - o E. Wagner volunteered Thanks, Erin!
 - o Motion: T. Hamblin; Seconded: M. Jones approved.
- Need UFS Rep because that used to be E. Frisbee 3 year term
 - o Would need to vacate current Senate seat and be replaced in your area
 - o L. Tessier volunteered and was nominated by T. Hamblin Thanks, Lisa!
 - o Motion: T. Hamblin; seconded: W. Shaffer approved.
 - o Now we'll need a UFS Alternate Rep (because that was L. Tessier) consider volunteering. The alternate does not vacate their current Senate seat.

Chancellor's Award Executive Committee Report – presented by L. Ciafardoni and C. Rossi

- Procedures for next year came out in July.
- Adjunct award comes in the Fall due to SUNY by November 9.
- Unclear if CADI will be able to financially fund these awards so we may need to consider alternative fund sources for this year
- New Award: SUNY Shared Governance Award we could self-nominate for this award in the future

Operations - D. Conklin

- 2 faculty at-large positions open
- Faculty Senators for Applied Technology and Nursing are open
- We will conduct elections in a few weeks to give folks time to acclimate to semester and consider running.

Questions about the Governor's New Policy Re: Covid 19 – M. Laliberte

- 1) Who is considered in the 5% population and how is that calculated?
 - Anyone who is coming to campus: faculty, staff, on-campus and commuter students
 - Campus population will be anywhere between 900-1600 in the next two weeks as students return
 - Shawn Brislin will be creating a database of students to help track students
 - If/when a campus is on Pause, the minimum will be two weeks. The infection rate will determine how long the Pause will be.
 - We would not wait for the state to tell us to pause, but rather end things sooner.
- 2) Can you share the communication plan if a similar situation to SUNY Oneonta were to happen here at SUNY Delhi?
 - Unclear what this question means.

- We would communicate our numbers to the campus as we see fit; if only one or two incidents, then perhaps not. We would work with the state health
- How will you communicate positive cases (e.g. separate email, Delhi Today)? How will the community know where we're at?
 - i. If 1 case tomorrow, not communicating that.
 - ii. Once someone tests positive, we do not control contact tracing. That is handled by the county health department.
 - iii. Less about "there was a case" and more about "this kind of behavior is happening on campus. There will be testing going on."
 - iv. The database we're creating could be turned into a dashboard, but why do people want to know this? We should continue to practice good social distancing regardless of if we know there are cases.
- 3) Could weekly updates be placed under the Planning Committees section of the COVID-19 page?
 - Notes for those meetings are posted on the President's website is this sufficient? Not everyone was aware that these notes are shared.
 - Covid-19 related policy changes are always sent out separately to the campus communication systems.

Open Discussion

Question to M. Laliberte: Do we have any legal responsibility to report student parties in regard to safety violations?

- We can keep students coming from campus if they have been behaving in unsafe ways (e.g. partying, not social distancing, not wearing masks, etc.).
- Police will be riding around town to monitor the situation
- Students really want to be here and are not looking to mess up.

M. Laliberte: We will be doing surveillance/pool testing of our students once all of our students are on campus (i.e. after September 15). Once a week 150 random students will be swab tested (10% of the population for 10 weeks in order to test 100% of the students by the end of the semester). Students may be coming to class late due to getting tested so please be patient. This is not baseline testing.
