- Students **MUST** meet with a financial aid counselor to set-up their summer aid
  - Online and Off-Site students **MUST** contact Justin Morgan 607-746-4537 to set-up their summer aid
- Complete a valid 2014/2015 FAFSA no later than **May 1, 2014**. We will not process your summer aid without a FAFSA on file.
  - Make sure you have money for books and living expenses, because summer aid is **NOT** available until **after** the summer term begins. Tuition is due **the first day** of class, so you may also need money to pay your tuition bill, if your financial aid is not completely processed by that date.
  - All notifications regarding summer financial aid will be sent to your SUNY Delhi email address.
  - Summer aid is contingent upon spring academic grades.** Any student who does not meet the SUNY Delhi [Satisfactory Academic Pursuit and Progress](#) standards in the spring term will **HAVE ALL SUMMER FINANCIAL AID CANCELED**.
  - Workload and funding limitations **make it impossible for Financial Aid to revise summer awards**. You will be expected to finance your summer program with the funds initially provided.
